- All minor Members, paid persons under 18 years of age, must be accompanied by a paid adult parent Member or paid legal guardian Member.
- Wristbands must be worn securely on the wrist and must be visible at all times during NOLA
  Time Fest II 2014 functions. Your wristband is proof of membership. Without it, you will not be
  allowed into any NOLA Time Fest II 2014 area. There are no exceptions.
- Wristbands are non-refundable, non-transferable and non-exchangeable for any reason.
   Wristband-sharing is not allowed. Wristbands are the property of NOLA Time Fest II 2014, Krewe du Who LLC and The Consortium of Genius LLC. If a wristband is lost, a new wristband must be purchased.
- Volunteers and Staff Members receiving membership must personally fulfill all requirements of those positions to receive the Staff or Volunteer rate.
- There will be a \$40.00 charge on all checks returned to Krewe du Who LLC for any reason.
